

# **SAFETY MEASURES**

A Message for All Team Members,

**SAFETY MEASURES:** As we continue to monitor the COVID-19 situation very closely, we wanted to reach out to share the actions we can take to keep our workplaces safe and clean for you, our employees, and the community. In addition to the safety measures below, we highly encourage employees to get vaccinated as eligibility and availability allows.

### **WAREHOUSE SAFETY MEASURES:**

- All employees are required to conduct a self-screening daily before the start of their shift. The self-screening includes not coming to work if you feel ill.
- On-going deep cleaning and disinfecting all high-touch areas in distribution centers, including workstations and bathrooms, with a
  disinfecting cleaner.
- Accessibility of hand sanitizers and disinfecting wipes for employees throughout the offices.
- Discouraging handshakes or physical contact with one another and discouraging in-person meetings at this time.
- Discouraging the use of shared workspaces and equipment Please use your assigned workspace and disinfect before allowing someone else to use.
- Employees instructed to maintain a physical separation from each other and customers of no less than 6 feet. Do not congregate in
  one area at any time for any reason. Masks usage required if within 6ft of any individual for unvaccinated employees. Fully vaccinated employees may remove facial coverings but should continue to practice all other safety procedures such as not reporting to
  work if feeling ill and physical separation of no less than 6 feet.
- Restricting access for outside visitors, vendors and contractors (policy available on <u>autowares.com/covid</u>)

#### **STORE SAFETY MEASURES:**

- All employees are required to conduct a self-screening daily before the start of their shift. The self-screening includes not coming to
  work if you feel ill.
- If you are waiting on a customer at the counter or during a delivery, you must wear a mask if you are not vaccinated. Failure to follow mask policy will result in discipline and/or discharge.
- Disinfecting all high-touch areas and common physical touch points within the stores, including workstations, product displays, restrooms, and counter areas with a disinfecting cleaner.
- Increasing accessibility of hand sanitizers for clients and employees at multiple stations across each store to protect the safety of the community in and outside our stores.
- · Discouraging handshakes or physical contact with one another.
- No signature required on paper invoices or Dash mobile to avoid direct contact.
- · Cleaning and disinfecting of DASH Devices by our delivery drivers.
- Wiping down of delivery vehicles at each change of vehicle operator.
- Using your assigned terminal and disinfect before allowing someone else to use (discourage shared workspaces where possible).
- Cash drawers and cash exchanges Washing or wiping your hands with disinfectant before and after any cash transactions is recommended. Also, cash drawer entry buttons and coin trays should be disinfected at the end of every shift.
- Credit Card Transactions Please have the customer insert the card themselves into the reader if possible. Washing or wiping your hands before and after the customer gives you their credit card.
- When delivering parts, please follow the customer's mask policy where applicable. If no guidelines are in place, wear a mask during interactions if you are unvaccinated Setting parts down instead of handing directly to a person is recommended.
- All employees are expected to maintain a physical separation from each other and customers of no less than 6 feet. Do not
  congregate in one area at any time for any reason. If your work area does not allow you to social distance by 6 feet, a mask must
  be worn for unvaccinated individuals. Fully vaccinated employees may remove facial coverings but should continue to practice all
  other safety procedures such as not reporting to work if feeling ill and physical separation of no less than 6 feet.
- Restricting access for outside visitors, vendors and contractors (policy available on <u>autowares.com/covid</u>).

## **CORPORATE SAFETY MEASURES:**

- All employees are required to conduct a self-screening daily before the start of their shift. The self-screening includes not coming to
  work if you feel ill.
- Disinfecting all high-touch areas and common physical touch points within the stores and distribution centers, including workstations and bathrooms, with a disinfecting cleaner.

- Accessibility of hand sanitizers and disinfecting wipes for customers/guests and employees throughout the offices.
- All employees are expected to maintain a physical separation from each other and customers of no less than 6 feet. Do not
  congregate in one area at any time for any reason. If your work area does not allow you to social distance by 6 feet, a mask must
  be worn for unvaccinated individuals. Fully vaccinated employees may remove facial coverings but should continue to practice all
  other safety procedures such as not reporting to work if feeling ill and physical separation of no less than 6 feet.
- Discouraging handshakes or physical contact with one another and discouraging in-person meetings at this time.
- Discouraging the use of shared workspaces and equipment Please use your assigned workspace and disinfect before allowing someone else to use.
- Work from home positions have been increased to separate employees within offices & cubicles wherever possible.

#### **SALES TEAM SAFETY MEASURES:**

- · Sales team members are required to conduct a self-screening prior to the start of their work day.
- · No physical contact with customers.
- Sales team members are not required to wear gloves. However, hand washing and/or disinfecting is mandatory between customer calls.
- We encourage the cleaning and disinfecting of vehicles and all electronic devices (phone, iPad, laptop, etc.) to be done once per day at a minimum.
- · All salespeople are expected to order Personal Protective Equipment using the HelpDesk form or source from a local store.
- All employees are expected to maintain a physical separation of no less than 6 feet from customers and other employees. Do not congregate in one area at any time for any reason.
- If you are visiting a customer, you must wear a mask if you are unvaccinated. Additionally, please follow the customer's mask policy where applicable. If no guidelines are in place, wear a mask during interactions if you are unvaccinated You should continue to practice social distancing of no less than 6ft.
- Riding with vendor representatives is allowed at this time if all parties are fully vaccinated. If unvaccinated, salespeople can meet the representative at the customer location or ride together while wearing face coverings. It is encouraged to call customers ahead of time to make sure bringing in a manufacturer representative is allowed.

**COVID TESTING AND VACCINATIONS** Auto-Wares health plans cover COVID-19 testing and vaccinations in full. To find a testing or vaccination site near you, please contact your local health care provider, health department, or pharmacy.
